### **HENRY SCHEIN MICROMD® EMR VERSION 7.5 RECEIVES ONC-ATCB 2011/2012 CERTIFICATION THROUGH CCHIT**

**System certification helps health care providers meet  
“Meaningful Use” requirements; qualify for financial incentives**

**Boardman, Ohio – January 11, 2010** – Henry Schein MicroMD®, a provider of proven and cost-effective practice management (PM) and electronic medical records (EMR) systems, today announced that through the Certification Commission For Health Information Technology (CCHIT), the Company’s EMR system version 7.5 has been certified by the U.S. Office of the National Coordinator - Authorized Testing and Certification Body (ONC-ATCB) for the American Recovery and Reinvestment Act (ARRA) 2011/2012 EHR Modular Certification.\*

The ONC-ATCB 2011/2012 certification program tests and certifies that Complete EHRs meet all of the 2011/2012 criteria and EHR Modules meet one or more, but not all, of the criteria approved by the U.S. Secretary of Health and Human Services (HHS) for either eligible health care provider or hospital technology. MicroMD EMR 7.5 is 2011/2012-compliant in accordance with the criteria adopted by the Secretary of Health and Human Services. The EHR certification enables health care providers to meet the Stage 1 meaningful use standards to qualify for the federal incentive payments established under ARRA. To receive such incentives, health care providers must meet the requirements outlined in the Centers for Medicare & Medicaid Services (CMS) EHR Incentive Program. MicroMD EMR 7.5 currently meets 20 of the 25 Final Rule Stage 1 requirements.

In addition to Modular Certification, Henry Schein MicroMD is on track to achieve Complete Certification in the first quarter of 2011, meeting all 25 Final Rule Stage 1 requirements. Modular certification is the most recent Henry Schein MicroMD has attained to ensure its EMR delivers value to customers. Previously, the MicroMD EMR system received certifications through Surescripts, multiple state Boards of Pharmacy, including those of Ohio, Nevada and Washington, as well as Ambulatory EHR certification, which it has maintained since 2006. MicroMD EHR 7.0 is currently a CCHIT Certified® 2008 Ambulatory EHR.

“We are delighted that MicroMD EMR 7.5 has been awarded modular certification,” says Don Quackenbush, Director of Product Development for Henry Schein MicroMD. “Providers are under pressure to achieve meaningful use and we are committed to delivering the technology to support their efforts. MicroMD not only provides robust and easy-to-use electronic medical record functionality, but helps practices remain ahead of the regulatory and reimbursement curve.
